I further agree that if any litigation or claim results arising out of, pertaining to, or in relation to my participation in the Activity, and the Owners or the Association are named as parties or joined as parties to such litigation or claim, I agree to hold them harmless, defend and indemnify them in regard to any judgment entered against them and in regard to their litigation expenses, including but not limited to reasonable attorneys' fees, costs and out-of-pocket expenses.
